# 1. DEMURRAGE

## 1.1 IMPORT DEMURRAGE

Each terminal will bill and collect their own demurrage according to their published tariff, except for the terminals listed below.

For the following terminals MSC will pass through terminal demurrage charges at cost:

## 1.2 EXPORT DEMURRAGE

### ALL TERMINALS:

MSC will pass through demurrage charges at cost.

## 2. DETENTION

### 2.1 IMPORT DETENTION

The import detention charges, after the expiration of the free time, for the use of the carrier's container inside the marine terminal of railroad or container yard facilities until the container has been delivered to the lawful receiver of the goods or its representative, will be calculated as set forth below.

#### ALL TERMINALS:

Free time will start the first working day after individual container discharge.

### 2.2 EXPORT DETENTION

The export detention charges, after the expiration of the free time, for the use of the carrier's container inside the marine terminal until the container has been loaded on the vessel, will be calculated as set forth below.

### 3. PER DIEM

The Per diem charges, after the expiration of the free time, for the use of the carrier's container (full or empty) outside of the marine terminal or railroad or container yard facilities until it is returned to the carrier's custody at the carriers designated place of return, will be calculated as set forth below.
